JFS provided care planning, care management, respite care, music and memory, friendly visitors, and counseling to clients. We continue the writing program that offers two workshops on "Creative Aging" and "Writing through Grief" and will be adding a third workshop in the coming year. The monthly Caregiver Support Group which includes a respite component has reached maximum participation. We continue to provide the Music and Memory program to families facing the challenges of Alzheimer's disease and other forms of dementia. "Gleeful" a dementia choir has begun this year. It is for individuals diagnosed with dementia and their caregivers and is facilitated by a music therapist.

Eligibility for emergency assistance depends on where the funds came from. The Park City funding was specific to Summit County and recipients were mostly referred to us from counseling staff in the area's public school system. This funding was mostly for housing.

Government funding required that recipients had to have been impacted by COVID-19. This funding was for housing and utility assistance.

Internal funds were disbursed to clients impacted by COVID-19 who needed help with rent, utilities or car repairs if client needed transportation for work and/or child care.

Refugee assistance was disbursed to clients referred to us by partnering agencies like UHR, DWS and Catholic Community Services.

All funds were paid to a third party. Recipients had to have identification, and supporting documentation like a lease agreement, utility bill or auto repair bill.

Food from the pantry is given to anyone who says they need it. Some demographic information is taken at the time food is disbursed.
