This serves as a great tool for both the client and counselors. In 2016, 2200 units of counseling were provided to 438 individuals. The Parenting Plus Program assists families with relationship and parenting skills. This program also includes concurrent programming for their children and a communal family dinner. This program is primarily targeted to low income families.**
