**With the continued financial impact of the COVID-19 pandemic, Emergency Assistance was the most significant service provided by JFS in terms of financial expenditures. We supplied more than \$300,000 in emergency aid to pay for rent, car payments, medical expenses, and other needs for families in crisis. More than 4000 families were helped in 2022.**

**Counseling:**

**All of our counseling services and programs remained available via virtual platforms during 2022. Staff continued weekly meetings with each other, including meetings of the Clinical team, to provide peer support and supervision. More than 4,000 hours of reduced-fee counseling services were offered in 2022 to more than 800 clients.**

**Aging Services:**

**JFS Provides care planning, care management, respite care, music and memory, and counseling to aging clients. Our Arts and Aging initiative includes the Gleeful Choir (a choir for people with dementia and their caregivers), facilitator hours and an Arts and Aging Coordinator. We provide a monthly Caregiver Support Group which includes a respite component. We continue to provide the Music and Memory program to families facing the challenges of Alzheimer's disease and other forms of dementia.**

The Park City funding was specific to Summit County and recipients were mostly referred to us from counseling staff in the area's public school system. This funding was mostly for housing.

Government funding required that recipients had to have been impacted by COVID-19. This funding was for housing and utility assistance. Internal funds were disbursed to clients impacted by COVID-19 who needed help with rent, utilities or car repairs if client needed transportation for work and/or child care.

Refugee assistance was disbursed to clients referred to us by partnering agencies like UHHR, DWS and Catholic Community Services. All funds were paid to a third party. Recipients had to have identification, and supporting documentation like a lease agreement, utility bill or auto repair bill.

Food from the pantry is given to anyone who says they need it. Some demographic information is taken at the time food is disbursed.
